## 2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 24 September 2024. The actual risk can vary significantly if you cash in at an early stage and you may get back less. ## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

## 5. How long should I hold it and can I take money out early?

### Recommended holding period: 5 months and 3 weeks

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 24 September 2024 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
