1. What is this product?

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 30 November 2028. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very likely to impact our capacity to pay you.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance over a period of up to 5 years. 3. What happens if Deutsche Bank AG, London Branch is unable to pay out?

In case of a crisis of the issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. 5. How long should I hold it and can I take money out early?
