## 1. What is this product?

### Type

German law governed interest rate-linked notes / Return depends on the performance of the reference rate / Full capital protection against market risk

### Term

The product has a fixed term and will be due on 15 December 2026.

### Objectives

The product is designed to provide (1) a return in the form of variable interest payments calculated by reference to the **reference rate** and (2) repayment of the **product notional amount** on the **maturity date**.  
**Interest:** On each **interest payment date** you will receive an interest payment calculated by multiplying the **product notional amount** by the applicable **interest rate** and then applying the **day count fraction** to adjust this amount to reflect the length of the relevant **interest period**. ## 2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 15 December 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. ## 5. How long should I hold it and can I take money out early?

### Recommended holding period: 10 months
