1. What is this product?

Term The product has a fixed term and will be due on 21 November 2023.

Objectives The product is designed to provide (1) a return in the form of variable interest payments calculated by reference to the **reference rate** and (2) repayment of the **product notional amount** on the **maturity date**.

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 21 November 2023. The actual risk can vary significantly if you cash in at an early stage and you may get back less. 3. What happens if Deutsche Bank AG, London Branch is unable to pay out?

5. How long should I hold it and can I take money out early?
