You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Term The product has a fixed term and will be due on 28 February 2023.

Objectives The product is designed to provide (1) a return in the form of variable interest payments calculated by reference to the **reference rate** and (2) repayment of the **product notional amount** on the **maturity date**.

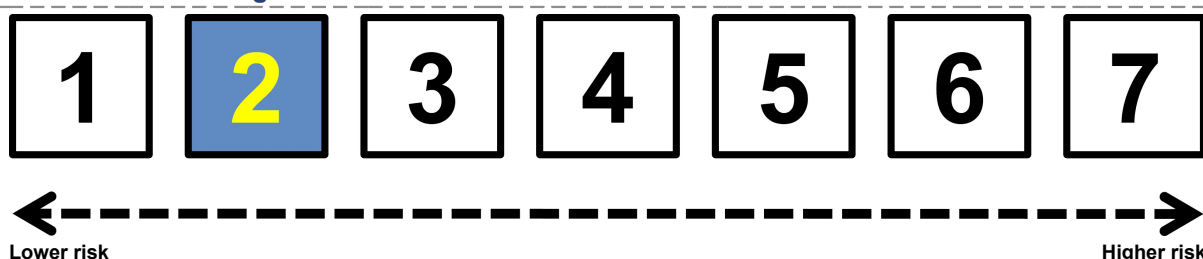

2. What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until 28 February 2023. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 month and 1 week
