1. What is this product?

The product has a fixed term and will be due on 11 November 2032, subject to an early redemption. The product is designed to provide (1) a return in the form of fixed rate interest payments and (2) repayment of the product notional amount on termination of the product.

The product notional amount will be repaid either (a) on the maturity date or (b) if we exercise our option to terminate the product prior to the maturity date, on the relevant call payment date Early termination following a call: We have the right to terminate the product with at least 5 business days' notice prior to each call payment date. In this case, the product

will terminate and you will on such call payment date receive, in addition to a final interest payment, a cash payment equal to the call payment of EUR 1,000.00. No interest payments will be made after such call payment date. The relevant dates are shown in the table below.

Maturity date

Interest rate: The interest rate for an interest period will depend on the number of calendar days in that interest period on which the range accrual reference level is within the range accrual range. The interest rate will be calculated as (1) 4.20% per annum multiplied by (2) the number of calendar days during the relevant interest period on which the range accrual reference level is within the range accrual range, divided by (3) the actual number of calendar days in the relevant interest period.

Termination on the maturity date: If the product has not terminated early, on the maturity date you will receive EUR 1,000.00.

2. What are the risks and what could I get in return?

Risk indicator

The risk indicator assumes you keep the product until 11 November 2032. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Inflation erodes the purchasing value of cash over time and this may result in the decline in real terms of any capital reimbursed or interest you may be paid under the investment.

You are entitled to receive back at least 100.00% of your capital. However, this protection against future market performance will not apply if you cash in before maturity or in case of immediate termination by the issuer.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the **reference rate** over a period of up to 5 years. In the case of an early redemption, it has been assumed that no reinvestment has occurred. The stress scenario shows what you might get back in extreme market circumstances. This product cannot be easily cashed in. If you exit the investment earlier than the recommended holding period, you do not have a guarantee and you may have to pay extra costs.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

You are exposed to the risk that the issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. 5. How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 11 November 2032 (maturity), although the product may terminate early.

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
