The product has a fixed term and will be due on 23 July 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the **maturity date** you will receive a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the **final reference level** divided by (B) 135.69. However, if this cash payment exceeds EUR 127, you will only receive EUR 127 (the maximum payment) and if it is less than EUR 90, you will receive EUR 90 (the minimum payment).

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

You do not have any entitlement to a dividend from the **underlying** and you have no right to any further entitlement resulting from the **underlying** (e.g., voting rights).



5. How long should I hold it and can I take money out early?
