Termination on the maturity date: On the maturity date you will receive:

- if the final reference level is above the barrier level, a cash payment equal to EUR 100; or
- if the final reference level is at or below the barrier level, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the final reference level divided by (B) the strike level.

Under the product terms, certain dates specified above and below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

### Recommended holding period: 1 year and 2 months

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 23 November 2026 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (where the product is listed) or (2) off-exchange.
