The product has a fixed term and will be due on 23 September 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- if the final reference level is at or above 806.18, a cash payment directly linked to the performance of the underlying.
 The cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference level divided by (B) 806.18. However, if this cash payment exceeds USD 148, you will only receive USD 148 (the maximum payment);
- 2. if the final reference level is at or above 644.944 and below 806.18, a cash payment equal to USD 100; or
- 3. if the **final reference level** is below 644.944, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the **final reference level** divided by (B) 644.944.

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 23 September 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 2 weeks and 3 days

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4.
