## 1. What is this product?

Objectives	<p>(Terms that appear in <b>bold</b> in this section are described in more detail in the table(s) below.)</p> <p><u>Investment allocation:</u> This product is split into two different asset allocations: part of the <b>unit reference amount</b> will be initially invested into cash generating a coupon payment (the cash allocation) and the other part will expose the investor to the <b>underlying</b> (the underlying investment allocation). The exposure between the respective allocations will be adjusted during the lifetime of the product if one or more trigger events occur. On the <b>initial valuation date</b>, 60.00% of the <b>unit reference amount</b> will be invested into the cash allocation and 40.00% of the <b>unit reference amount</b> will be invested into the underlying investment allocation.</p> <p><u>Trigger event:</u> A trigger event will occur if the <b>reference level</b>, on any scheduled trading day during the <b>trigger observation period</b>, is at or below the corresponding <b>trigger level</b> for the first time. If a trigger event occurs, 20.00% of the <b>unit reference amount</b> will be deducted from the cash allocation and immediately reinvested into the underlying investment allocation. For the avoidance of doubt, multiple trigger events can occur at the same time.</p>

Coupon: On the **maturity date** you will receive a coupon payment equal to the sum of daily coupon amounts accrued on each calendar day during the **coupon period**. A daily coupon amount in respect of a calendar day is calculated as the coupon rate of 6.45% per annum multiplied by the outstanding cash allocation on such day and divided by 360. If a trigger event occurs, the daily coupon amounts that will be accrued on each calendar day will decrease following the occurrence of such trigger event and therefore the value of your coupon payment will be reduced. If all trigger events have occurred, no daily coupon amounts will be accrued following the occurrence of the last trigger event.

Underlying investment allocation: On the **final valuation date**, the underlying investment allocation amount will depend on the performance of the **underlying** and on the number of trigger events that have occurred. This amount will be equal to (A) the underlying investment allocation on the **initial valuation date** multiplied by (i) the **final reference level** divided by (ii) the **initial reference level** plus (B) the sum of, for each trigger event that has occurred (if any), (i) 20.00% of the **unit reference amount** reinvested into the underlying investment allocation multiplied by (ii) the **final reference level** divided by (iii) the **reference level** in respect of the scheduled trading day on which such trigger event occurred.

Termination on the maturity date: On the **maturity date** you will receive a cash amount equal to (A) the remaining cash allocation (if any) plus (B) the underlying investment allocation.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

You do not have any entitlement to a dividend from the **underlying** and you have no right to any further entitlement resulting from the **underlying** (e.g., voting rights).

In case of immediate termination, the return (if any) may be significantly lower than the purchase price, but will reflect the product's market value and, if higher, any minimum redemption (alternatively, in some cases the corresponding compounded amount may be paid out at the product's scheduled maturity). Instead of immediate termination, the issuer may also amend the terms and conditions.



## 2. What are the risks and what could I get in return?

#### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to impact our capacity to pay you.

### 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

You are exposed to the risk that the issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. ### 5. How long should I hold it and can I take money out early?

#### Recommended holding period: 1 year

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 8 February 2027 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
