## 1. What is this product?

The product has a fixed term and will be due on 16 July 2024.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- if the final reference price is at or above EUR 217.16, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the final reference price divided by (B) EUR 217.16. However, if this cash payment exceeds EUR 130, you will only receive EUR 130 (the maximum payment);
- 2. if the final reference price is at or above EUR 162.87 and below EUR 217.16, a cash payment equal to EUR 100; or
- 3. if the **final reference price** is below EUR 162.87, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the **final reference price** divided by (B) EUR 162.87.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

# 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

# Recommended holding period: 3 months and 2 weeks

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 16 July 2024 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (where the product is listed) or (2) off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
