The product has a fixed term and will be due on 6 January 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- 1. if the **final reference level** is at or above 3,882.29, a cash payment equal to (i) EUR 100 plus (ii) an amount directly linked to the performance of the **underlying**. This amount will equal (i) EUR 200 multiplied by (ii) (x) (A) the **final reference level** divided by (B) 3,882.29 minus (y) 100.00%. <u>However, if this cash payment exceeds EUR 146, you will only receive EUR 146 (the maximum payment)</u>; or
- 2. if the **final reference level** is below 3,882.29, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the **final reference level** divided by (B) 3,882.29.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.



The product is intended for private clients who pursue the objective of general capital formation/asset optimization and have a short-term investment horizon. This product is a product for clients who have sufficient knowledge and / or experience to make an informed investment decision. The investor can bear losses up to the total loss of the capital invested and attaches no importance to capital protection.

#### 2. What are the risks and what could I get in return?







The risk indicator assumes you keep the product until 6 January 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

#### 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

### Recommended holding period: 9 months and 1 week

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 6 January 2025 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (where the product is listed) or (2) off-exchange.
