The product has a fixed term and will be due on 26 August 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- if the final reference level is at or above 818.06, a cash payment directly linked to the performance of the underlying.
  The cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference level divided by (B) 818.06. However, if this cash payment exceeds USD 147.50, you will only receive USD 147.50 (the maximum payment);
- 2. if the final reference level is at or above 654.448 and below 818.06, a cash payment equal to USD 100; or
- 3. if the **final reference level** is below 654.448, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the **final reference level** divided by (B) 654.448.

# 2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 26 August 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. # 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?
