The product has a fixed term and will be due on 3 March 2026.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- if the final reference price is at or above USD 26.60, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference price divided by (B) USD 26.60. However, if this cash payment exceeds USD 132, you will only receive USD 132 (the maximum payment);
- 2. if the final reference price is at or above USD 19.95 and below USD 26.60, a cash payment equal to USD 100; or
- if the final reference price is below USD 19.95, a cash payment directly linked to the performance of the underlying.
   The cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference price divided by (B) USD 19.95.

The product is intended for private clients who pursue the objective of general capital formation / asset optimization and have a short-term investment horizon. This product is a product for clients who have sufficient knowledge and / or experience to make an informed investment decision. The investor can bear losses up to the total loss of the capital invested and attaches no importance to capital protection.

## 2. What are the risks and what could I get in return?







The risk indicator assumes you keep the product until 3 March 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?
