You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type German law governed notes

Term The product has a fixed term and will be due on 1 August 2023.

Objectives The product is designed to provide (1) a return in the form of (i) fixed rate interest payments on each **fixed rate payment date** and (ii) variable interest payments calculated by reference to the **reference rate** on each **floating rate payment date** and (2) repayment of the **product notional amount** on the **maturity date**.

(Terms that appear in **bold** in this section are described in more detail in the table(s) below.)

Interest: On each **interest payment date** you will receive an interest payment calculated by multiplying the **product notional amount** by the applicable **interest rate** and then applying the **day count fraction** to adjust this amount to reflect the length of the relevant **interest period**. When purchasing this product during its lifetime, the purchase price does not include accrued interest on a pro rata basis.

However, you will also be required to pay accrued interest on a pro rata basis if you purchase the product during its lifetime.

Amounts to be paid under the securities are determined by reference to an interest rate. Interest rates are, as part of benchmark reform, currently in the process of transition to alternative rates. 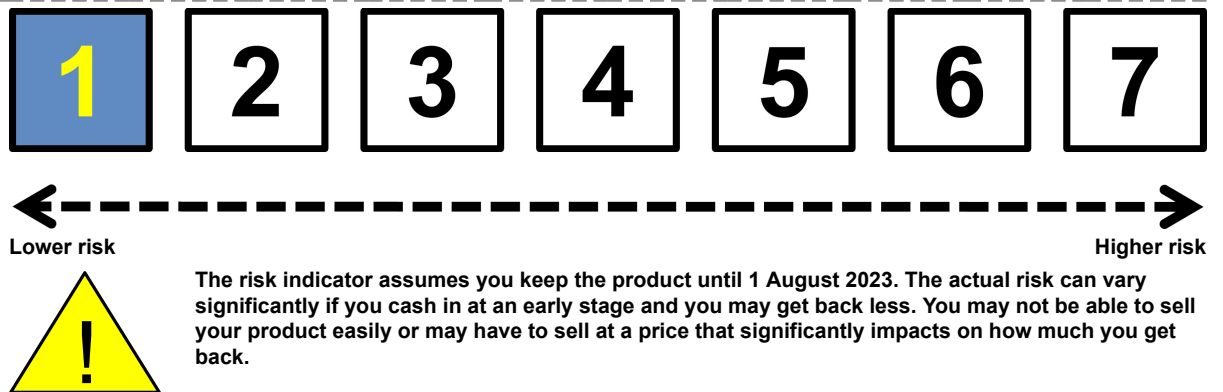

2. What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 2 months and 2 weeks

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. No fees or penalties will be charged by the issuer for any such transaction. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
