2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 2 years and 2 months. The actual risk can vary significantly if you cash in at an early stage and you may get back less. 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

You are exposed to the risk that the issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. 4. What are the costs?
