The product has a fixed term and will be due on 16 July 2024.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- 1. if the **final reference price** is at or above USD 23.29, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the **final reference price** divided by (B) USD 23.29. However, if this cash payment exceeds USD 134, you will only receive USD 134 (the maximum payment);
- 2. if the final reference price is at or above USD 17.468 and below USD 23.29, a cash payment equal to USD 100; or
- 3. if the **final reference price** is below USD 17.468, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the **final reference price** divided by (B) USD 17.468.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

### 2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 16 July 2024. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

## 5. How long should I hold it and can I take money out early?

## Recommended holding period: 3 months and 2 weeks

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 16 July 2024 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
